The outcome is increased agricultural productivity in the four project provinces. There are four outputs (i) productivity-enhancing rural infrastructure constructed and rehabilitated; (ii) productivity-and impact enhancing initiatives adopted; (iii) capacity of national, provincial, and district agencies strengthened to enable a sector development approach; and (iv) efficient and effective delivery of subprojects and project management.
