## 1. Background

1. Land titling activity of NRI-AF Project is delivered to all farmers in command areas of all subprojects from Phase I to IV. Land certificates guarantee legal rights of the farmers over the parcels in the command areas of the subprojects. Securing land tenure through land titling builds up confidence of the farmers on their land ownership and is expected to promote investments into rice and other commercial crops in a longer-term view. In addition, strengthening of land ownership reduces conflicts and encroachments over the farmland, and contributes to poverty reduction.

2. The number of target households, who obtain land ownership certificate was originally set at 5,000 households in the PAM.

3. Land titling activities of NRI-AF Project have following features.

- (1) Land titling activity of NRI-AF Project targets only individual (private) paddy land in the command area of subprojects, because the objective of the land titling activities is to enhance effectiveness of PRI rehabilitation of the Project.
- (2) The Project supports issuance of both (a) permanent land titles by PONRE/DONRE and (b) agricultural land booklet/certificates by PAFO/DAFO.

## 2. Objectives

4. The objectives of land titling activity are as following.

- (1) Securing land tenure and access to agricultural land (paddy field) for all farmers in the NRI-AF Project area through upgrading land ownership status from land user to land owner.
- (2) Maintaining and securing agricultural land (paddy field) that have benefited from the project in order not to decrease the area or change the form of land use to other purposes
- (3) Plans and strategies of agricultural land management and allocation as well as permanent land titling to be implemented and expended in the province and districts
- (4) Performance and skills of provincial and district officials to be strengthened and improved

## 3. Implementation Procedures

5. Based on the actual implementation at Phase I subprojects in Oudomxay, implementation procedure of land titling activities has been modified as the following six (6) steps.

- ... Consultation with PAFO/PPO, DAFO/DCO, PONRE and DONRE
- ... Establishment of Provincial/District Project Steering Committee for Land Titling Activities
- ... Notification to the villages/ WUGs
- ... Village consultations including gender consultation
- ... Agreement by villages/ WUGs
- ... Setting up of Village Agricultural Land Management Committee at each target village
- ... Setting up of a Village Mediation Team at each target village

#### Step 2: Implementation and Budget Plan at Provincial Level

- ... Approval of provincial implementation and budget plan by PPO/PAFO and PONRE (DG and head of land unit)
- ... Submission of provincial implementation and budget plan to MAF
- ... Approval of provincial implementation and budget plan by MAF

#### Step 3: Preparation of Field Survey

- ... Preparation of base maps (Land Management Dep. of MONRE) and other required equipment / materials including interview form
- ... Setting up of Land Titling Field Team at district level
- ... Training for Land Titling Field Team members

#### Step 4: Implementation of Field Survey, Mediation and Database Management

- ... Field survey by Land Tiling Field Team
- ... Interview land owner by DAFO and DONRE respectively
- ... Check land-related documents such as record of tax payment
- ... Mediation of land disputes
- ... Data entry and adjustment of the database (quality control of the database)
- ... Day-to-day meeting for instruction of land titling procedure to villagers (about 5 households per day)

#### Step 5: Public Display, Dealing of Grievances and Concurrence

- ... Public display for grievances
- ... Resolving grievances
- ... Confirmation of accuracy and no unsolved disputes on the prepared maps

#### Step 6: Verification and Issuance of Land Certificates and Hand-Over

... Verification and issuance of both (a) Permanent Land Certificate, and (b) Agricultural Land Booklet/ Certificate

#### 4. **Project Achievement**.

6. 16 subprojects of Phase I, II and III have implemented and issued land title certificate in total 10,580 certificates for 7,002 HHs in the project command area. Below (Table1) is show the overall land title certificate and their ownership.
