1. Background

Para.9 of Aid Memoire of ADB review mission (19 June – 4 July 2018) suggests that Participatory Catchment Management Pilot Activities (PCMPA) shall be conducted during November – December 2018. PCMPA is composed of five (5) activities as (i) dissemination of the maps/land use plans to raise awareness of stakeholders, and as basis for designing soil and water conservation measures; (ii) briefing of concept of PCMPA, which will be implemented in critical areas within the watershed through community participation; (iii) selection of pilot villages, target households, and critical areas of PCMPA; (iv) establishment of village committee for PCMPA; and (v) preparation of implementation plan, schedule and agreement with stakeholders.

2. PCMPA Implementation Plan in 4 Provinces

Based on the village consultations in November 2018, target areas and villages for PCMPA were selected through discussions with the relevant PPOs/DCOs as well as the potential target villages.

In December 2018, all 4 PPOs and relevant 4 DCOs surveyed at the target villages to identify the activities that the current shifting cultivator shape for the Project to support such as i) assisted natural regeneration, ii) dissemination of PCMPA and training, and iii) tree planting.

All the 4PPOs have already submitted the detailed PCMPA implementation plans to NPMO (Lao version) by 01 March 2019, the total estimated budget is US\$82,128.

The PCMPA Implementation Plans of each province are summarized in **Table 1**.
