**Project Description:** The Northern Rural Infrastructure Development Sector Project – Additional Financing was approved by the Asian Development Bank (ADB) on 31 May 2017. The project impact is improved rural household incomes in the four northern provinces of Bokeo, Louang-Namtha, Oudomxai, and Phongsali. The outcome is increased agricultural productivity in the four project provinces. There are four outputs (i) productivity-enhancing rural infrastructure constructed and rehabilitated; (ii) productivity-and impact enhancing initiatives adopted; (iii) capacity of national, provincial, and district agencies strengthened to enable a sector development approach; and (iv) efficient and effective delivery of subprojects and project management.
